The following mandatory documents shall be affixed to a fully completed supplier database form for further consideration by the

- 1. Fully Completed and initialed registration (Note Commissioner's stamp is required)
- 2. Original and Valid Tax Clearance Certificate Issued by SARS
- 3. Certified Copy of CIPC (previously known as CIPRO) registration certificate
- 4. Company Profile
- 5. Original certified copies of shareholders / directors / owners / members identity documents.
- 6. Cancelled cheque / confirmation letter from the bank (Bank stamp is required on the form)
- 7. BBBEE certificate

ALL service providers or suppliers who were previously or are currently providing services or supplies to the Moses Mabhida Stadium MUST also re-register as they will not be automatically included in the database.

The Moses Mabhida Stadium is committed to the provisions of the Preferential Procurement Policy Framework Act 5 of 2000; the Municipal Finance Management Act 56 of 2003; and the Supply Chain Management Framework Act of 2005.

- 1. Blacklisted companies appearing on the National Treasury database and that are prohibited from conducting business with public entities, shall not be considered.
